## **Project's Events**

One of the first tasks of the partners was to organise a focus group in each partner country, with participants being VET trainers and tourism professionals working directly in the tourism sector. The aim of the focus groups was to help clarify the overall common needs in the partner countries in terms of what VET trainers lack and what tourism stakeholders need to promote low-carbon tourism.

Based on the outputs from the focus groups, a national report has been produced for each country which is included in the Innovative VET Curriculum under Result 1.

## What is Low Carbon Tourism?

Low carbon tourism can be defined as a phenomenon that includes any form of low energy tourism. This means that carbon dioxide emissions produced by related transport, accommodation and other activities are kept to a minimum. Low-carbon tourism is mainly associated with rail or coach transport, short to medium distances, domestic tourism, longer stays and low carbon accommodation.



In contrast, energy and carbon intensive forms are mainly associated with air, car or cruise transport combined with long distances and high energy accommodation.

## **Bugibba Meeting**

The kick-off meeting of the VINCI project partners took place on Friday 11th March 2022 in Bugibba, Malta. This first meeting was attended by representatives from all seven partner organisations. Representatives from each partner organisation who attended the meeting introduced themselves to each other, and presented their organisations and their added value to the project. During the meeting, the project outputs and the Gantt chart were reviewed. First steps, forms of cooperation, tasks of each partner and deadlines related to the project for the first six months of the project were discussed. 


